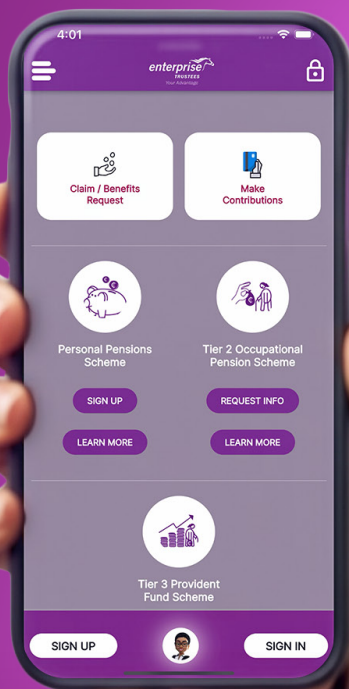

*Board Chairman's Statement to Members
of the Enterprise Tier 2 Occupational
Pension Scheme (ET2OPS).*

Dear Valued Scheme Members,

It is my pleasure to welcome you to the virtual Annual General Meeting of the Enterprise Tier 2 Occupational Pension Scheme (ET2OPS). On behalf of the Scheme Board, I would like to express my appreciation for your continued trust and confidence in choosing the Scheme as your preferred long-term investment vehicle.

I will begin with an overview of the economy within which the Fund operated in the year under review and proceed with a detailed account of the performance of the Scheme in 2025. I will conclude with our expectations for the year ahead.

Economic Overview

Ghana's economy demonstrated remarkable resilience in 2025, building on the recovery achieved in the previous year. The year was characterized by stronger macroeconomic stability, declining inflation, improved fiscal performance, and renewed investor confidence. Continued implementation of economic reforms, supported by prudent fiscal and monetary policies, contributed significantly to strengthening economic fundamentals and sustaining the growth momentum.

Economic activity remained robust throughout the year, with real GDP growth reaching 6.0%, up from 5.8% in 2024. Growth was driven largely by the services sector, particularly information and communication technology, transport and storage, education, and financial services. Agriculture also recorded improved performance, supported by stronger crop production, while manufacturing continued to contribute positively to overall economic expansion.

A notable development during the year was the significant strengthening of the Ghanaian cedi. Supported by strong external sector performance, increased foreign exchange inflows from gold and cocoa exports, higher gross international reserves and improved market confidence. The cedi appreciated against the major international currencies and contributed to greater exchange rate stability and helped ease imported inflationary pressures.

Economic Overview (Continued)

Inflation declined sharply during the year, from 23.8% at the end of 2024 to 5.4% by the end of 2025. This was supported by exchange rate stability, improved food supply conditions, and the continued implementation of tight monetary and fiscal policies. The significant moderation in price pressures created a more favorable environment for households and businesses enhancing overall economic confidence.

With inflation firmly on a downward trajectory, the Bank of Ghana adopted a more accommodative monetary policy stance during the year, reducing the Monetary Policy Rate in successive steps to support economic activity while maintaining price stability. Though easing interest rates improved financing conditions and strengthened prospects for private-sector growth, they also signaled a transition toward a lower-yield environment for fixed-income investors.

Fiscal and external sector indicators also improved significantly. Public debt levels declined as a proportion of GDP, supported by fiscal consolidation efforts and stronger revenue performance. At the same time, international reserves increased substantially, providing a stronger buffer against external shocks and reinforcing confidence in the country's economic outlook. These developments, together with improved sovereign credit ratings and stronger investor sentiment, underscored Ghana's progress towards macroeconomic stability and sustainable growth.

Overall, 2025 marked a year of consolidation and renewed economic confidence. The combination of sustained growth, lower inflation, currency stability, and strengthened fiscal and external positions provided a solid foundation for continued economic expansion and long-term development.

Outlook for the Ghanaian Economy in 2026

The outlook for Ghana's economy remains positive but cautious, supported by improving macroeconomic fundamentals and policy discipline. Growth is expected to remain strong in the medium term.

The IMF projects GDP growth of 4.8%, aligning with the 2026 budget estimate, driven by continued expansion in the services sector, an industry recovery, and sustained agricultural productivity.

Inflation is expected to remain within or close to the Bank of Ghana's medium-term target band (6–10%), supported by stable exchange rate conditions and prudent monetary policy. Interest rates are expected to remain low in line with inflation trends, which may reduce borrowing costs but also lead to lower yields on fixed income instruments.

The exchange rate is expected to remain relatively stable, supported by strong export earnings and improved external sector performance. However, risks to the outlook remain, including global economic uncertainties, commodity price volatility, and potential external financing constraints.

Fiscal consolidation efforts are expected to continue, with a focus on debt sustainability, revenue mobilization, and expenditure control.

These measures are critical to maintaining macroeconomic stability and investor confidence as Ghana exits the IMF's extended credit facility in 2026.

Scheme Performance

The Scheme has returned a Compounded Annual Growth Rate (CAGR) of 20.18%. The Scheme, year on year, continues to record remarkable investment returns. For the year 2025, the Scheme earned an investment income of GHS732 million on fixed income instruments and GHS355 million on Equities, Mutual Funds and Alternative investments.

Growth in Assets Management during the year 2025

The ET20PS Scheme, which was established in 2012 with an Asset Under Management (AUM) of GHS1.50 million, has grown to GHS5.99 billion as at 2025. The Scheme’s AUM, comprising contributions received and returns generated, stood at GHS5.99 billion, up from the previous year, 2024 of GHS4.71 billion, representing growth of 27%. This growth is attributed to a net contribution of 29% and returns of 71%.

The Scheme complied with the investment guidelines issued by the regulator for the period under review.

Membership of the Scheme

The Membership of the Scheme grew by 9.78% over the previous year, 2024. The total Membership at the end of 2025 stood at 494,564 (2024: 450,475)

Benefit Payout

Total benefit payout for 2025 was GHS208 million compared to GHS121 million in 2024. The total retirement benefit paid was GHS66.36 million, and the highest benefit paid for an individual member in the year was GHS15.50 million.

Member Education and Engagement Activities

Over the period, the Scheme has constantly engaged Members through varied activities to ensure transparency and accountability of the Scheme. Some of these activities during 2025 are;

Tomorrow Today Webinar Series:

To promote awareness on the importance of retirement planning and sound financial management, Enterprise Trustees continued its "Tomorrow Today" webinar series, streamed live on YouTube, Facebook, and Zoom. The webinar remains a key platform for engaging Members and the general public on relevant and timely financial topics, while fostering informed decision-making for a secure financial future.

Young and Invested Podcast Series:

In 2025, Enterprise Trustees continued the "Young and Invested" podcast series, airing nine (9) episodes designed to promote financial literacy among young people. The podcast focused on equipping young professionals with practical insights on money management, investing, retirement planning, and other key financial decisions, empowering them to take charge of their financial futures and build long-term financial security.

New Joiners Webinar:

The Scheme organized quarterly webinars for all new Members to educate them on the National Pensions Act, 2008 (Act 766), the operations of the Scheme, and how to stay informed about the growth and performance of their pension funds. These sessions provided an important platform for enhancing Members' understanding and promoting active engagement with their retirement savings.

Scheme Annual General Meeting (AGM):

The Scheme successfully held its 2nd Annual General Meeting (AGM) on Thursday, 28th August 2025, providing Members with an opportunity to engage with the Trustees on the Scheme's performance and operations during the year under review. The meeting featured the presentation of the 2024 Audited Financial Statements, updates on key initiatives and achievements, and discussions on matters of interest to Members. It also reinforced the Scheme's commitment to transparency, accountability, and the delivery of sustainable value to its Members.

Quarterly Advantage Report and Newsletter:

The Scheme circulated its quarterly Advantage Report and Newsletter to Members, providing timely updates on the Scheme's performance and key financial developments. The publications also featured educational content on retirement planning and broader long-term financial wellness topics, aimed at supporting Members in making informed decisions towards a secure financial future.

Key Regulatory Activities

Appointment of New Chief Executive of the National Pensions Regulatory Authority (NPRA)

In January 2025, the President of the Republic of Ghana, His Excellency John Dramani Mahama appointed Mr. Christopher Boadi-Mensah as Chief Executive Officer of the National Pensions Regulatory Authority (NPRA).

Mr. Boadi-Mensah brings extensive industry experience, having previously served as Chief Executive Officer of Byll Wych Insurance Brokers and Serene Insurance (2016–2021).

His appointment was made at a pivotal time, amid ongoing government efforts to reform and modernize the pensions sector in line with global best practices, with a focus on strengthening transparency, accountability, and operational efficiency. Concurrently, the Executive Management Team was reconstituted to align with the evolving strategic direction of the Authority.

Issuance of Corporate Governance Guidelines

In March 2025, the Regulator gazetted Corporate Governance Guidelines to strengthen governance standards across the pension industry, with mandatory compliance for all key stakeholders.

The Guidelines focus on eligibility and appointment requirements for Directors, Trustees, and Management, clearly defined roles and responsibilities, effective Board structures and committees, adherence to general governance standards including independence and internal controls, and the promotion of transparency, accountability, and sound financial reporting practices.

Scheme Governance

Quarterly Trustee Meetings

The Scheme Board and its sub-committees held quarterly meetings to review the affairs of the Schemes in accordance with section 38 of the National Pensions Act, 2008 (Act 766).

The sub-committees under the Scheme Board effectively discharged their respective mandates during the period under review, contributing significantly to the overall governance and operational efficiency of the Scheme.

Scheme Governance

Constitution of the Education and Sensitization Committee

In accordance with the gazetted Corporate Governance Guidelines issued by the Regulator, National Pensions Regulatory Authority (NPRA) in 2025, the Board established an Education and Sensitization Committee to complement the existing Committees of Audit & Compliance and Investment & Risk.

The Education and Sensitization Committee is a five-member committee mandated to enhance stakeholder engagement, promote awareness of the Scheme, and support the broader objective of fostering an informed and actively engaged Membership.

The Committee is primarily responsible for ensuring the effective implementation of the Consumer Protection Policy issued by the National Pensions Regulatory Authority (NPRA), as well as driving initiatives that strengthen member education and public confidence in the Scheme.

Scheme Strategy Session

The Trustee Board held a strategy session in May 2025 to review the Scheme’s performance, assess emerging risks and opportunities, and set strategic priorities for the period ahead. As part of the session, an official from the National Pensions Regulatory Authority was invited to provide insights on the Corporate Governance Guidelines, enhancing the Board’s understanding of regulatory expectations and compliance requirements.

Trustee Training

In accordance with Regulation 7 of Legislative Instrument (LI) 1990, Trustees periodically participate in learning and development programmes to maintain and enhance the skills and knowledge required to effectively manage the Scheme. These training sessions cover current regulatory and industry developments, as well as specific areas of Scheme activity where changes or adjustments have been implemented.

All Trustees were enrolled in a three-day training programme on Effective Administration of Private Pension Schemes, organized by the National Pensions College in November 2025. The programme was aimed at strengthening the capacity of Trustees to effectively discharge their fiduciary responsibilities, ensure compliance with regulatory requirements, and enhance the overall governance and administration of the Scheme.

Outlook for 2026

The Board of Trustees remains committed to delivering a secure, transparent, and rewarding pension Scheme for Members. Building on the progress made in previous years, we will continue to implement forward-looking strategies aimed at strengthening our investment portfolio through prudent diversification, enhanced risk management, and the adoption of innovative solutions to drive sustainable long-term growth.

Beyond investment performance, we will continue to deepen member engagement and maintain our focus on the ongoing Know Your Customer (KYC) initiative to ensure accurate and complete member records, enabling us to provide more personalized support and enhanced service delivery.

>> Report of the Trustees

The Trustees present their report together with the audited financial statements of the Enterprise Tier 2 Occupational Pension Scheme (the "Scheme") for the year ended 31st December 2025.

>> Establishment, Nature and the Status of the Scheme

The Scheme is a defined-contribution scheme which provides lump-sum benefits on retirement and such other ancillary benefits to Members who meet the qualifying conditions stipulated under the National Pensions Act, 2008 (Act 766) as amended.

The Scheme is a tax-exempt pension fund under the National Pensions Act, 2008 (Act 766) and any amendments made to it thereafter.

The Scheme's activities are bound by the provisions of the National Pensions Act, 2008 (Act 766) as amended, the Occupational and Personal Pension Schemes (General) Regulations, 2011 (L.I. 1990), guidelines formulated and published, and any Board directives that may be issued from time to time, as well as the Governing Rules of the Scheme.

The Trustees of the Scheme are ultimately responsible for the administration of the Scheme and their responsibility to the Scheme is established by a Trust Deed and Scheme Governing Rules approved on 1 November 2012.

The Scheme Governing Rules and the Trust Deed, both of which are subject to the National Pensions Act, 2008 (Act 766) as amended, form the basis of establishing the Scheme.

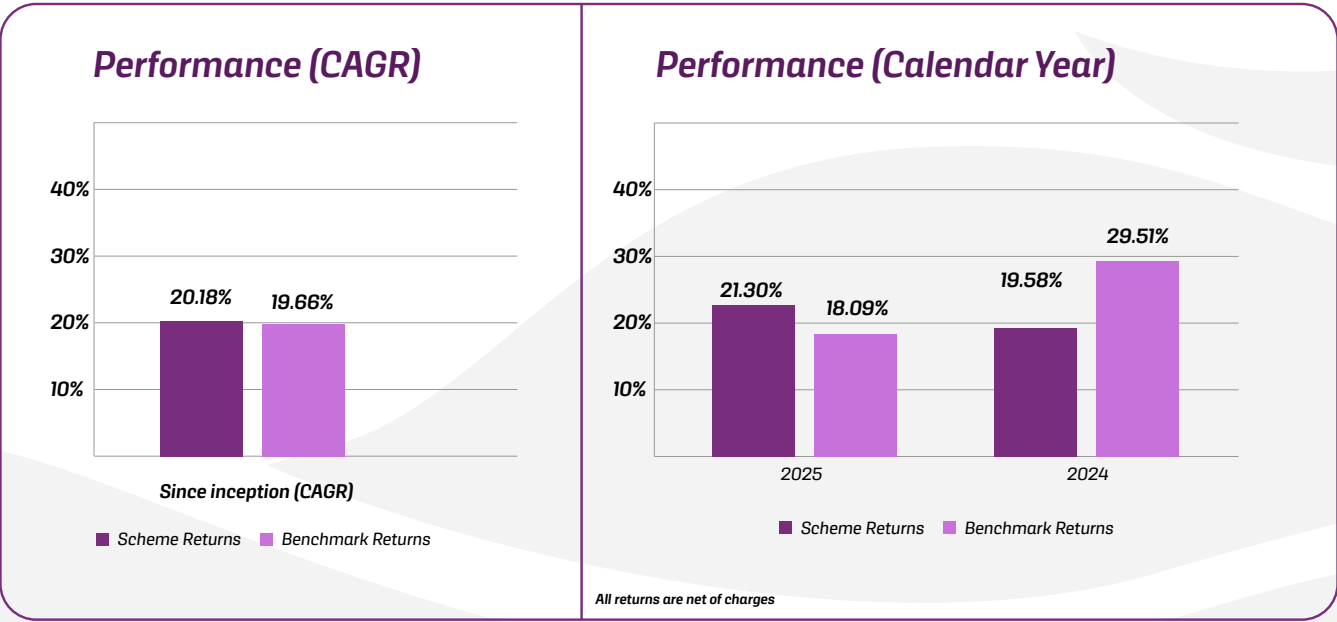

Objectives

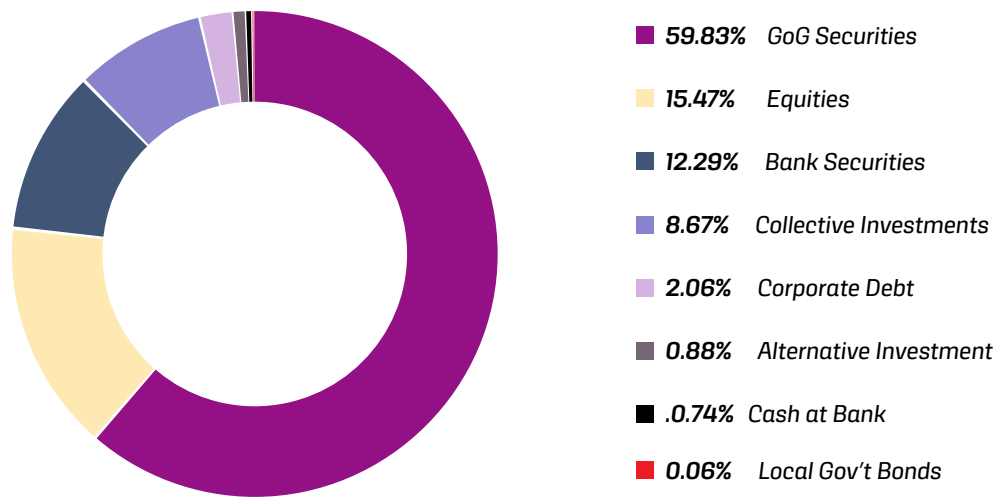

TO THE MEMBERS OF ENTERPRISE TIER 2 OCCUPATIONAL PENSION SCHEME Report on the Audit of the Financial Statement

Our Opinion

In our opinion, the accompanying financial statements give a true and fair view of the financial position of Enterprise Tier 2 Occupational Pension Scheme (the "Scheme") as at 31 December 2025, and of its financial performance and its cash flows for the year then ended, in accordance with International Financial Reporting Standards issued by the International Accounting Standards Board ("IFRS Accounting Standards") as adopted by the Institute of Chartered Accountants, Ghana (ICAG) and in the manner required by the Occupational and Personal Pension Schemes (General) Regulations, 2011.

What We Have Audited

We have audited the financial statements of Enterprise Tier 2 Occupational Pension Scheme for the year ended 31st December 2025. The financial statements comprise:

- The statement of net assets available for benefits as at 31st December 2025;
- The statement of changes in net assets available for benefits for the year then ended;
- The statement of movement in net assets available for benefits for the year then ended;
- The statement of cash flows for the year then ended; and
- The notes to the financial statements include a summary of material accounting policy information and other explanatory information.

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs). Our responsibilities under those standards are further described in the Auditor's responsibilities for the audit of the financial statements section of our report. These matters were addressed in the context of our audit of the Scheme's financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. We have determined that there are no key audit matters to communicate in our report.

- Conclude on the appropriateness of the Trustees' use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Scheme's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Scheme to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with the Trustees regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

From the matters communicated with the Trustees, we determine those matters that were of most significance in the audit of the financial statements of the current period and are therefore the key audit matters. We describe these matters in our auditor's report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

- iii. The Scheme's balance sheet (statement of net assets available for benefits) and profit and loss account (statement of changes in net assets available for benefits) are in agreement with the books of account; and
- iv. With respect to the provisions of Section 35 of the Occupational and Personal Pension Schemes (General) Regulations, 2011, we did not identify any instances of non-compliance based on procedures we performed.

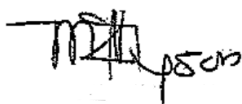

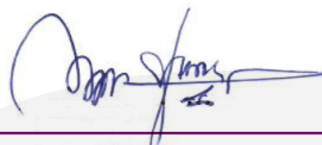

1. Scheme information

The Scheme is a defined Contribution scheme which provides lump sum benefits and such other ancillary benefits to Members who meet the qualifying conditions stipulated under the National Pensions Act, 2008 (Act 766) as amended. The Scheme is a master trust with Membership open to companies and their employees.

As of the date of reporting, the number of participating companies and employees of the Enterprise Tier 2 Occupational Pension Scheme is 4,212 and 49,456 respectively.

2. Summary of material accounting policies

The material accounting policies adopted in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented, unless otherwise stated.

(a) Basis of preparation

The financial statements of the Scheme have been prepared in accordance with International Financial Reporting Standards issued by the International Accounting Standards Board ("IFRS Accounting Standards") as adopted by the Institute of Chartered Accountants, Ghana (ICAG) and in the manner required by the Occupational and Personal Pension Schemes (General) Regulations, 2011 (L.I. 1990) and relevant guidelines.

The financial statements summarise the transactions of the Scheme and deal with the net assets available to the Members. They do not take into account obligations to pay benefits that fall due after the end of the year.

Basis of measurement and use of estimates and judgements

The financial statements have been prepared under the historical cost convention, except as modified by the revaluation of financial assets at fair value through profit or loss. The preparation of financial statements in conformity with IFRS Accounting Standards requires the use of certain critical accounting estimates. It also requires the Trustees to exercise judgement in the process of applying the Scheme's accounting policies. Areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial statements, are disclosed in note 3.

(b) Changes in Accounting Policies and Disclosures

(i) New and amended standards adopted by the Scheme

The Scheme has applied the following standards and interpretations for the first time to financial reporting periods commencing on or after 1 January 2025:

- Lack of Exchangeability – Amendments to IAS 21, 'The Effects of Changes in Foreign Exchange Rates'

The adoption of the amendments above did not have any impact on the amounts recognised in prior and current periods and is not expected to significantly affect future periods.

(ii) New and amended standards not yet adopted by the Scheme

Certain new accounting standards, amendments to accounting standards and interpretations have been published that are not mandatory for 31 December 2025 reporting periods and have not been early adopted by the Scheme. These standards, amendments or interpretations are not expected to have a material impact on the Scheme in the current or future reporting periods and on foreseeable future transactions.

(c) Functional and Presentation Currency

The financial statements are presented in Ghana Cedis (GH¢), which is the Scheme's functional and presentation currency. Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rate of exchange ruling at the end of the reporting period. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the Statement of Changes in Net Assets Available for Benefits.

(d) Contributions

Contributions are recognised in the period in which they fall due. The contributions are in compliance with rates as set out in the National Pensions Act, 2008 (Act 766), as amended and the Scheme's Governing Rules.

(e) Benefits

Benefits are recognised in the period in which they fall due. Benefits represent all valid benefit claims paid/payable during the year in compliance with the National Pensions Act, 2008 (Act 766), as amended and the Scheme Governing Rules. Benefits payable to seceding Members are recognised as liabilities in the period in which they fall due.

(f) Investment Income

Dividend income from investments is recognised when the shareholders' right to receive payment has been established. Interest income is recognised for all interest-bearing instruments using the effective interest method. Interest income includes coupons earned on fixed income investments and accrued discount and premium on Treasury bills and other discounted instruments.

(g) Financial Assets and Liabilities

Initial recognition and measurement:

Financial assets and financial liabilities are recognised when the Scheme becomes a party to the contractual provisions of the instrument. Regular way purchases and sales of financial assets are recognised on the trade date, the date on which the Scheme commits to purchase or sell the asset. At initial recognition, the Scheme measures a financial asset or financial liability at its fair value plus or minus transaction costs that are incremental and directly attributable to the acquisition or issue of the financial asset or financial liability. When the fair value of financial assets and liabilities differs from the transaction price on initial recognition, the Scheme recognises the difference as follows:

(i) When the fair value is evidenced by a quoted price in an active market for an identical asset or liability (i.e. a Level 1 input) or based on a valuation technique that uses only data from observable markets, the difference is recognised as a gain or loss.

(ii) In all other cases, the differences are deferred, and the timing of recognition of deferred day-one profit or loss is determined individually. It is either amortised over the life of the instrument, deferred until the instrument's fair value can be determined using market-observable inputs, or realised through settlement.

Classification and subsequent measurement:

Financial assets

The Scheme applies IFRS 9 and classifies its financial assets in the following measurement categories:

- At fair value through profit or loss (FVPL); and
- At amortised cost.

The classification depends on the Scheme's business model for managing the financial assets and the contractual terms of the cash flows. For assets measured at fair value, gains and losses will be recorded in the Statement of Changes in Net Assets Available for Benefits.

The Scheme classifies its financial assets at amortised cost only if the asset is held within a business model whose objective is to collect the contractual cash flows, and the contractual terms give rise to cash flows that are solely payments of principal and interest. The business model reflects how the Scheme manages the assets in order to generate cash flows. Factors considered by the Scheme in determining the business model for a group of assets include past experience on how the cash flows for these assets were collected, how the asset's performance is evaluated and reported to the Board of Trustees, how risks are assessed and managed, and how the fund managers are compensated. Where the business model is to hold assets to collect contractual cash flows or to collect contractual cash flows and sell, the Scheme assesses whether the financial instruments' cash flows represent solely payments of principal and interest (the 'SPPI test').

Impairment:

The loss allowances for financial assets are based on assumptions about the risk of default and expected loss rates. The Scheme uses judgment in making these assumptions and selecting the inputs to the impairment calculation, based on the Scheme's past history, existing market conditions, as well as forward looking estimates at the end of each reporting period.

Modification of financial assets:

If the Scheme renegotiates the terms of financial assets and the changes are substantially different, it derecognises the original financial asset and recognises a "new" asset at fair value and recalculates a new effective interest rate for the asset. The date of renegotiation is consequently considered to be the date of initial recognition for impairment calculation purposes, including for the purpose of determining whether a significant increase in credit risk has occurred. However, the Scheme also assesses whether the new financial asset recognised is deemed to be credit-impaired at initial recognition, especially in circumstances where the renegotiation was driven by the debtor being unable to make the originally agreed payments. Differences in the carrying amount are also recognised in profit or loss as a gain or loss on derecognition.

If the renegotiated terms are not substantially different, the renegotiation or modification does not result in derecognition, and the Scheme recalculates the gross carrying amount based on the revised cash flows of the financial asset and recognises a modification gain or loss in profit or loss. The new gross carrying amount is recalculated by discounting the modified cash flows at the original effective interest rate (or credit-adjusted effective interest rate for purchased or originated credit-impaired financial assets).

Derecognition:

The Scheme derecognises a financial asset when the contractual rights to the cash flows from the asset expire, or it transfers the rights to receive the contractual cash flows on the financial asset in a transaction in which substantially all the risks and rewards of ownership of the financial asset are transferred, or in which the Scheme neither transfers nor retains substantially all of the risks and rewards of ownership and it does not retain control of the financial asset. Any interest in transferred financial assets that is created or retained by the Scheme is recognised as a separate asset or liability.

Financial liabilities:

The Scheme's holdings in financial liabilities represent mainly benefits payable and administrative expenses payable to Members and service providers, respectively. Such financial liabilities are initially recognised at fair value and subsequently measured at amortised cost.

Derecognition

The Scheme derecognises a financial liability when its contractual obligations are discharged, cancelled, or expired.

Offsetting financial instruments:

Financial assets and liabilities are offset and the net amount presented in the net assets available for benefits when, and only when, the Scheme has a legal right to offset the amounts and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

Fair value measurement:

The determination of fair values of financial assets and financial liabilities is based on quoted market prices or dealer price quotations for financial instruments traded in active markets. For all other financial instruments fair value is determined using valuation techniques.

Write-offs:

The Scheme writes off financial assets as bad debt when the following have occurred; either upon liquidation, inability to locate issuer for over 6 months. Such events provide an indication that there is no reasonable expectation of recovery. It is the Scheme's policy to follow up on all defaulters and to use reasonable means to recover bad debt after write off.

(h) Provisions

Provisions are recognised when the Scheme has a present legal or constructive obligation as a result of past events, it is more likely than not that an outflow of resources will be required to settle the obligation, and the amount can be reliably estimated. Where the obligation is expected to be settled over a period of years, the provision is discounted using a discount rate appropriate to the nature of the provision.

(i) Cash and Cash Equivalents

Cash at bank represents cash held with licensed financial institutions.

(j) Administrative Expenses

Administrative expenses are recognised in the Statement of Changes in Net Assets Available for Benefits when incurred.

3. Critical accounting estimates and judgements

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. In particular, critical estimates are made by the Trustees in determining the fair value of investments that are not traded in an active market.

Determining fair values:

The determination of fair values for financial assets for which there is no observable market price requires the use of valuation models. The fair value hierarchy of the financial assets of the Scheme is set out in note 19.

Measurement of the expected credit loss allowance and derecognition gain or loss:

The measurement of the expected credit loss allowance for financial assets measured at amortised cost is an area that requires the use of models and significant assumptions about future economic conditions and credit behaviour (e.g. the likelihood of customers defaulting and the resulting losses). The method applied in the determination of the impairment charge on the Scheme's financial assets measured at amortised cost is set out under note 17 of these financial statements.

17. Financial risk management, objectives and policies

Risk management framework

The Trustees have overall responsibility for the establishment and oversight of the Scheme's risk management framework. The Scheme's risk management policies are established to identify and analyse the risks faced by the Scheme, to set appropriate risk limits and controls, and to monitor risks and adherence to limits. The Trustees, through standards and procedures, aim to develop a disciplined and constructive control environment in which all Trustees understand their roles and obligations. The Trustees are responsible for monitoring compliance with risk management policies and procedures and for reviewing the adequacy of the risk management framework in relation to risks faced by the Scheme.

Credit risk

An Investment Asset Allocation Policy, which is aimed at ensuring that the Trustees position the Scheme's portfolio to amass optimal returns within the changing market environment and expectations while ensuring that the corpus, risk, and performance of the investment portfolio remain relatively safe and sound, is reviewed and approved by the Board of Trustees. The Scheme's policy on credit risk is to minimise its exposure to counterparties with a perceived higher risk of default by dealing only with counterparties that meet the standards set out in the NPRA guidelines and the Scheme's investment policy statement.

17. Financial risk management, objectives and policies

The Scheme adopts a three-stage approach for impairment assessment based on changes in credit quality from initial recognition:

- **Stage 1** – Where there has not been a significant increase in credit risk (SICR) since initial recognition of a financial instrument, an amount equal to 12 months' expected credit loss is recorded. The expected credit loss is computed using a probability of default occurring over the next 12 months. For those instruments with a remaining maturity of less than 12 months, a probability of default corresponding to the remaining term to maturity is used.
- **Stage 2** – When a financial instrument experiences a SICR subsequent to origination but is not considered to be in default, it is included in Stage 2. This requires the computation of expected credit loss based on the probability of default over the remaining estimated life of the financial instrument.
- **Stage 3** – Financial instruments that are considered to be in default are included in this stage. Similar to Stage 2, the allowance for credit losses captures the lifetime expected credit losses.
- **POCI:** Purchased or originated credit impaired (POCI) assets are financial assets that are credit-impaired on initial recognition. POCI assets are recorded at fair value at original recognition, and interest income is subsequently recognised based on a credit-adjusted EIR. The ECL allowance is only recognised or released to the extent that there is a subsequent change in the expected credit losses.

The Scheme has defined credit impaired financial assets as when the issuer becomes 90 days past due on its contractual payments or when there is qualitative information of the issuer being in significant financial difficulty. The expected loss model is developed using statistical techniques based on actual historical data. The expected loss is calculated using parameter estimates including the probability of default ('PD'), exposure at default ('EAD'), and loss given default ('LGD').

The Scheme utilised the 30-day past due definition to determine a significant increase in credit risk.

17. Financial risk management, objectives and policies

While cash and cash equivalents are also subject to the impairment requirements of IFRS 9, the identified impairment loss was immaterial.

Liquidity risk:

Liquidity risk is the risk associated with a situation where a Scheme does not have sufficient financial resources available to meet all of its obligations and commitments when they fall due or cannot access them at a high cost. A threshold amount has been set based on historical accrued benefits paid to ensure that this risk is mitigated wholly. The benefits payable, administrative expenses payable, and other payable amounts disclosed in the financial statements are the contractual undiscounted cash flows. These balances are due within 12 months and equal their carrying balances.

Market risk:

Market risk is the risk associated with changes in market prices, such as interest rates, equity prices, and foreign exchange rates, that will affect the Scheme's income or the value of its portfolio of financial instruments. This systematic risk cannot be mitigated through diversification.

Price Risk:

Listed equity securities are susceptible to market price risk arising from uncertainties about future values of the investment securities. Keen attention is paid to the equity market to realise capital gains on equity securities. At 31 December 2025, if the prices of all equity securities and collective instruments had increased/decreased by 2% with all other variables held constant, the 'increase in net assets available for benefits' for the year would have been GH¢1,501,251 higher/lower (2024: GH¢3,707,120).

Interest Rate Risk:

Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Scheme's investment horizon has moved towards shorter-tenor investments, as they offer less interest rate risk. For certain bonds with issuers other than the Government of Ghana, investments are placed with a floating rate to hedge against this risk. At 31 December 2025, a change of 1% in interest rates with all other variables held constant would have resulted in an increase/decrease in the 'Net Assets Available for Benefits' of GH¢44,535,000 (2024: GH¢32,964,000), arising substantially from the change in market values of debt securities.

18. Tax Status of the Scheme

The Enterprise Tier 2 Occupational Pension Scheme has been approved by the National Pensions Regulatory Authority and is exempt from income tax on its investment income in accordance with Section 94 (2) of the Income Tax Act, 2015 (Act 896) as amended.

19. Fair Value Measurements

Fair Value Hierarchy:
IFRS 7 specifies a hierarchy of valuation techniques based on whether the inputs to those valuation techniques are observable or unobservable. Observable inputs reflect market data obtained from independent sources; unobservable inputs reflect the Scheme's market assumptions. These two types of inputs have created the following fair value hierarchy:

Level 1: Quoted prices in active markets for identical assets or liabilities. This level includes equity securities listed on the Ghana Stock Exchange.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly (as prices) or indirectly (derived from prices). This level includes collective investments and alternative investments.

Level 3: Inputs for the asset or liability that are not based on observable market data (unobservable inputs). This level includes equity investments and debt instruments with significant unobservable components.
